The Kingdom of Cambodia has received a loan from the Asian Development Bank toward the cost of Skills for Competitiveness Project (S4C), and it intends to apply part of the proceeds of this loan to payments under the Contract Reference No. ITC-W-2 for the Upgrading Work (Renovation of Stormwater Reservoir) at Institute of Technology of Cambodia (ITC), Phnom Penh.

The Project Implementation Unit of the Institute of Technology of Cambodia (ITC) now invites sealed bids from eligible and qualified bidders for the Upgrading Work (Renovation of Stormwater Reservoir) at Institute of Technology of Cambodia (ITC), Phnom Penh. The construction period is **06 months** from date of notification to commence.
- 3. Procurement will be conducted through National Open Competitive Bidding Procedures outlined in the Government's Standard Operating Procedures on Procurement for Externally Financed Projects/ Programs.
- 4. This invitation is open to all qualified bidders from eligible source countries of as described in the Bidding Document.
- 5. Bidders attention is drawn to Sub Clause 6.3 of the Instructions to Bidders (ITB) on the Qualification requirements. Qualification requirements include:
 - Average Annual Construction Turnover: The average annual volume of construction work of the successful Bidder over the last 3 years (2020, 2021, and 2022) shall be at least USD 888,870.00.
 - Specific Similar Experience: Experience as prime contractor in the construction of at least two contracts for work of a similar nature or complexity equivalent to the works within the last five (5) years (2018, 2019, 2020, 2021, and 2022) and with the minimum contract value which shall be at least USD 355,548.00 for each contract. Documentary evidence such as completion certificates/handing over certificates/final invoices, shall be submitted by the bidder.
 - Liquid Assets: The minimum amount of liquid assets and/or credit facilities net of other contractual commitments of the successful Bidder shall be USD 222,217.50.
